



At the outset, Prof. A. M. Patil presented introductory remarks. In his address, he clarified about the evolution of the law and how implementation of the law has become inevitable in the present context. Mrs. R. K. Baghele is a Protection Officer. She actively deals with the cases of domestic violence. Her speech was the hallmark of the programme. She highlighted the significance of the said law citing examples from her personal experience. She insisted that in order to safeguard 'Right to Equality' under Article 14 & 15, the society needs to understand the right of every single woman to safe and secure workplace. She also suggested concrete measures in which a woman employee or a girl student may protect her modesty. She emphasized the need to give a Karate Training to girl students so that she may protect herself instead of being reliant on men. Adv. Mrs.P.K. Rangari also guided students. In her address, she pointed out how a law can play a gigantic role in improving the working conditions for women. She underlined the significance of different legal provisions especially made for the upliftment of women.

Prof. V. K. Wagh also expressed her views on the occasion. She tried her level best to boost the morale of students by providing examples on how to tackle a situation when any girl finds herself in embarrassing situation. She assured all of the students to shun inhibition and speak out loud against any injustice perpetrated against them. She also promised students to timely redress the complaints of sexual harassment received from any of the girl students.
