(PREVENTION, PROHIBITION AND REDRESSAL ACT) 2013"

With reference to the above cited subject, we hereby submit a report on the half day workshop conducted regarding implementation of "sexual harassment of women at work places (prevention, prohibition and redressal act) 2013". The programme was held at 11.00 am on $27^{\text {th }}$ February 2017 in the college premises as per the directions of Maharashtra State Commission for Women. The programme was chaired by Dr. A. S. Dwivedi, Principal, M. B. Patel College of Arts, Commerce \& Science, Sadak Arjuni, Dist. Gondia. Mrs. R. K. Baghele, Women's Protection Officer, Department of Women and Child Development, Sadak Arjuni, Dist. Gondia and Adv. Mrs.P.K. Rangari, Legal Practitioner, Session Court, Sadak Arjuni, Dist. Gondia were the guest of honour. Prof. V. K. Wagh and Prof. A. M. Patil who are acting in the capacity of members of the 'Internal Complaint Committee' newly formed as per the guidelines of Maharashtra State Commission for Women and the 'Saksham Report' of University Grants Commission and Prof. C. V. Bisen were also present on the dais.

At the outset, Prof. A. M. Patil presented introductory remarks. clarified about the evolution of the law and how implementation of the law inevitable in the present context. Mrs. R. K. Baghele is a Protection Officer. She highlighted the significance of the said law citing examples from her perner experience. She insisted that in order to safeguard 'Right to Equality' under Article 14; the society needs to understand the right of every single woman to safe and secure Wortoples
She also suggested concrete measures in which a woman employee or a girl student protect her modesty. She emphasized the need to give a Karate Training to girl studentrs that she may protect herself instead of being reliant on men. Adv. Mrs.P.K. Rangari a guided students. In her address, she pointed out how a law can play a gigantic role improving the working conditions for women. She underlined the significance of diffec legal provisions especially made for the upliftment of women.

Prof. V. K. Wagh also expressed her views on the occasion. She tried her level boe to boost the morale of students by providing examples on how to tackle a situation when ant girl finds herself in embarrassing situation. and speak out loud . She assured all of the students to shun inhibition any injustice perpetrated against them.
